# President's Update



January to March 2023 had a bit on. New Year holidays, severe weather events and personal income tax reports. In terms of NZIDE specific work, Waka Kotahi NZ Transport Agency did another round of consultation on the Driver Licence Improvement Programme (DLIP). DLIP was setup by the Education Employment and Training (EET) Ministers in June 2022. **DLIP in summary**, from August to October 2022 a *long list* was created from feedback then summarised in a *short list*. In November options were put on a spectrum from 1. do the minimum to 6. do it all. General consensus was around 4. The specifics on that have not been publicly released. Make contact if you'd like to know what was on the long list, the short list and the NZIDE response. In February 2023, the short list was re-done as 7 seven shifts to improve the driver licencing system. Two questions were asked about each shift, what impact will it have and what's missing. The 7 shifts are to improve access, equity and safety through the Graduated Driver Licencing System (GDLS). The GDLS remains unchanged. The July 2019 Schiff Report was the last formal review of the GDLS in New Zealand.

**7x Regional Advisor roles have been created at Waka Kotahi NZ Transport Agency**. These new roles are to improve access to driver licencing through community driving programmes. An I endorsed instructor or community driving programme manager with established community relationships would appear to be a natural fit for these roles. Check this link for the job description. NZIDE and the Learning System for Driving Instructors (LSFDI) are mentioned. Applications close 16 April 2023. 4x train the trainer roles were announced in August 2022 as part of the DLIP. They are expected to be advertised in late April 2023 (thank you to Wendy from the Driving Change Network for the train the trainer roles update).

**VTNZ Testing Officers as Driving Instructors**. In late March 2023, Instructors in the Northland and Auckland regions contacted

our regional delegate Matthew Campbell (Matt). It was about testing officers being given the ok to instruct as driving instructors if they have an I endorsement. The intent was to level the playing field for testing officers who now see instructors testing as Community Driver Testing Officers (CDTO's). Two trials of CDTO's have been done, one in Te Tai Tokerau Northland and one in Tairawhiti Gisborne. Visit the Driving Licencing Improvement Programme for information about each trial. A response was given to Matt for distribution to members that asked. Contact Matt or myself if you have further questions. Happy Easter!
